Introduction to Disability Inclusion

Service Provider ToR

Background

The Pass It Back program aims to provide children with structured sport and life skills learning opportunities in a safe, inclusive environment, that supports social and emotional learning and allows them to positively contribute to their communities.

Rationale

ChildFund Sport for Development (S4D) team has identified a need for services around training on disability inclusion for staff and activity leaders. A key factor that underpins this need is that donors are increasingly holding development actors accountable for their work around inclusivity and their capacity to effectively engage vulnerable, marginalized and excluded populations as well as ensure safe and positive environments for all stakeholders.

The following needs have been identified as key to Rugby for Development work delivering more inclusive programming:

- a. Improving knowledge of the basic principles of disability inclusion among staff, partners and Coaches.
- b. Introducing best practices around language and terminology.
- c. Establishing a set of 'next steps' practices and processes that can be implemented and monitored over time.

Service Outcomes

This proposal outlines a set of services that ChildFund seeks to engage a service provider to support:

- Deliver one day training to ChildFund S4D staff and key partner leaders (8 Senior Coaches and 3
 Network Chairpeople) in Hoa Binh city, Hoa Binh province to build understanding of disability
 inclusion principles and practices and Vietnamese government commitments toward disability
 inclusion, as well as develop a set of good practice disability inclusion protocols that a Rugby
 network can adopt to improve disability inclusion in their work;
- 2. Deliver a one day training in Kim Boi and a one day training in Tan Lac to S4D Coaches to build understanding of disability inclusion principles and how to take key steps to implement good practice in their work with players as well as how to collect accurate data using contextually appropriate processes and terminology specifically using the Washington Group Short Set.

Training Package Objectives

The training package will deliver the following:

- 1. To socialise the disability inclusion principles, key terminology, and the context of disability inclusion in Vietnam.
- 2. To support Vietnamese national staff in understanding government commitments and support for inclusion and where and how disability inclusion sits in Vietnam government contexts.
- 3. To support Vietnamese national staff to understand how sport activities can be created or adapted to be more inclusive of people of all abilities.
- 4. To support training on the understanding and use of the Washing ton Group Short Set of questions, as well as general practices around contextually appropriate data collection.

As disability inclusion in sports is of increasing importance to international S4D program and building on ChildFund's experience in international safeguarding in sport, a pre-training meeting with key ChildFund staffs to prepare the training agenda and content overview is requested to ensure content is aligned with international sport commitments. A post-training meeting is requested to support ChildFund in



documenting training learnings and actions toward development of creation of a set of best practice disability inclusive programming integrations and ensuring equitable representation of persons with disabilities in demographic and impact data.

Staff and Key Partner Leader Training Content

It is proposed that the content of the training should cover the following:

- 1. Introduction to disability inclusion principles;
- 2. Introduction to the context of disability inclusion in the Vietnam (history, progress, existing government policy and planning);
- 3. Key terms and language;
- 4. How to integrate a set of key practices ('first steps') into S4D operations and Rugby for Development programming;
- 5. The collection and use of Washington Group Questions.

A decision on the final content will be made during the formation of the training agreement.
